**CONDITIONS OF USE :**

**1.-** The motorcycle is given in perfect conditions, both mechanical and body, with a sealed odometer, in normal use conditions, and with all of the accessories. The lessee receives the reference vehicle with complete satisfaction and is obligated to pay the lessor, at the end of the contract and at market price, for:

- 1 -Missing accessories and parts of the vehicle, which were received at the moment it was rented.

**2.-** The fuel which the vehicle uses will be the responsibility of the lessee.-

**3.-** The return of the vehicle will be at the rental address, and at the date and time set beforehand. A non-return at the indicated date will generate, for the lessee, the payment of the respective rental plus a charge of 50% over the cost of the rental. The pick up of the vehicle by the lessor, in a place different than what was indicated, causes the lesser to pay for the costs of said service.

4.- Subleasing the vehicle, or using the vehicle for ends different than those related to tourism or personal use of the lessee, is prohibited.-

5.- The rented vehicle cannot leave the limits of the territory of the Republic of Chile, without previous written consent, which must be issued, in this case, by the lessor.-

6.- The damages and injuries caused to third parties, which are not caused by the state of maintenance of the rented vehicle, are the responsibility of the lessee, and therefore release TURISMO HARD ROAD from any responsibility.-

**GUARANTEE:** The lessee gives, as a guarantee of compliance to the described stipulations, the quantity of :.....(.....)

**INSURANCE:** The rented vehicle is insured, consequently, by the insurance company for the repairs due to damages which are covered according to the contracted policies, these are **Total loss, theft, fire and damages which may be provoked by third parties.** In case there is damage which is not covered by the insurance policy, or originates from some exclusion, the lessee must compensate the lessor for all of the prejudices caused. The lessee is responsible for giving notice to the lessor, in a maximum of eight hours from the occurrence of an accident or theft, and is obligate to give notice to the authorities, taking complete responsibility in case of abandonment of the vehicle. Damages or injuries caused to third parties are not covered by the insurance, if the rented vehicle is driven under the influence of alcohol or in a state of intoxication.-

**SPECIAL DECLARATION:** The lessee declares to have driving knowledge, the correct drivers license to operated the rented vehicle, and the necessary expertise for these ends. Accordingly, it releases TURISMO HARD ROAD of all wrong or improper use, incorrect operation or provocation from not giving truthful information in regards to the present declaration.

For everything related to the compliance or interpretation of this contract, the parties will submit to the jurisdictions of the Courts of the City of Santiago. This contract is signed at the date indicated in this document.
